The only section above that has a fiscal impact is the amendment to youth deer hunting age. As written, it appears that the age has been changed to be allowed for only 11 year olds and not 12 or 13 year olds. This would reduce revenue. Language clarification is needed.

Clarification is needed regarding the bill amendment. As written, the proposed bill would decrease revenue currently received for 12 & 13 year olds. There were 2,593 12&13 year old youth licenses issued for 2016 under the current law. It is unknown how many 11 year olds or 10 year olds who turn age 11 in the same year as the deer youth season there would be. As written, we estimate a loss in revenue of \$25,930 (2,593 x \$10).

Relating to youth hunting and the protection of bald eagles

**Chairman Porter:** Called the committee to order HB 1204. The clerk called roll call and read the purpose of the bill.

**Rep. Heinert:** This bill deals with a couple of things. The first is the age of the youth that are allowed to hunt in the state of ND. Under the apprentice hunter validation program, we're looking at changing the age from 16 to 12 otherwise the bill stays exactly as it is in the state law for the delegation under this program. The reason to move it to 12 is we have many more youth today getting interested in hunting at an earlier age, and provide the opportunity to go out earlier and learn to hunt and get involved in that sport. The second part of the amendment changes from the 12 or 13 birthday to the 11<sup>th</sup> birthday for the youth deer hunting season and that is only good for the white tail antlerless deer during the youth, same reasons. More parents want to get their sons and daughter involved. The third section is the golden eagle section. I've been asked why are we allowing the hunting of golden eagles and we are NOT allowing the hunting of golden eagles. We are making sure those zoos across ND that take in a damaged or injured golden eagle and try to rehab that eagle, have the authority to release that eagle back into the wild. There's a section of federal code that questions whether they have that authority so we are trying to give that authority to the director and make sure we have a paper trail to release them once they are rehabbed.

**Rep. Lefor:** The changes in the ages for youth hunting, how does that compare with other states?

**Rep. Heinert:** I do not know.

**Chairman Porter:** ND has no minimum age for hunting. So if you're hunting pheasants, you have to have a license. There's no minimum age for upland game. Deer hunting is still 14 for lottery system. SD is at 10 for their regular hunting season. Our youth season is the

compromise between what other states have done for their regular season where we do an early entry at age 12, they can have a special white tail doe tag in September youth season. Brings that age down to 11 if they've completed hunter ed.

**Rep. Devlin:** When I read Section 2 it looks to me like you're limited to people who have 11<sup>th</sup> birthday in that same year. Ok.

**Chairman Porter:** Game and Fish noticed and will have an amendment.

**Rep. Devlin:** Say someone turns 11 on December 31, in a worst case scenario they would be able to hunt.

**Rep. Bosch:** Line 10 an apprentice validation is only valid for one license year in a lifetime. They can only apply this one time starting at 12 or is it good for their whole life when they apply? So what happens when, they couldn't when they're 13 or 14, 15?

**Rep. Heinert:** 1 time event, correct under this section. It's a one-time event.

**Rep. Roers Jones:** Clarify when would you use an apprentice hunter license. Would it be for upland game or birds or things like that because it seems like it shouldn't be necessary for furbearers and shouldn't be necessary for the youth deer hunting. Is that accurate?

**Chairman Porter:** We'll let Game and Fish dive into that.

**Greg Link,** Chief of Conservation Communications for ND Game and Fish. He read Attachment #1 in support, Terry Steinwand's testimony, who was ill.

**Rep. Keiser:** With this amendment adopted, doesn't it change the fiscal note significantly?

I believe it goes away.

**Rep. Keiser:** It's important to get the correct fiscal note.

**Greg Link:** The apprentice portion doesn't really change the fiscal note. Basically all you're saying is you don't have to be certified for one year. You still have to buy the license, still required to do everything else, you just don't have to be hunter education certified.

**Rep. Keiser:** I understand that but based on the original bill you are going to lose \$25,000. That's not going to happen with the amendment. That goes to zero right?

**Greg Link:** That's correct if the second portion of the bill that deals with 11-12-13 year olds, as long as we put the 12-13 olds back in, that's where we would have lost the revenue. Correct.

**Chairman Porter:** Further questions? Further testimony in support? Opposition?

**Foster R. Hager,** Washburn, ND, representing Cass County Wildlife Club, Casselton, ND: We have 200 members, existence since 1931. We provide a rifle range open to the public,

trap range, educate about 70 young people in hunter education each year and provide a youth duck hunt. We're concerned about the Section amendment. A few years ago there was a movement to let 12 year olds hunt in regular season. We were against that and it looked like we'd lose. So I made a suggestion to the club, let's come up with 12 and 13 year olds who can hunt by themselves, don't have to compete against the big boys, and they'll be able to shoot a doe and automatically get a license. That became law. It appears each session this gets watered down. This bill a 10-year-old will hunt, if he's born on Dec. 31, turns 11, then he's 10 because the season opens September 15. If it would stop there maybe we could live with it. What will happen next session when someone has a child that doesn't fall into the right category, we don't know. A good example is, I got out of the service the day before I was 21. During that year I still couldn't drink beer until I turned 21. So are we going to lock this in and say 9 year olds can't hunt, that's a 5<sup>th</sup> grader that you're letting hunt in his own season. When does it stop? I got news for you the next session, if your 10<sup>th</sup> birthday falls in the year, you can hunt. Questions?

**Rep. Heinert:** Are you opposed to by the eleventh year, in the eleventh year, so a 10-year-old could hunt essentially? Are you opposed to that or you just opposed this could go down further in the future?

**Foster R. Hager:** Our club would go along with this if it's going to stop. Who says that Herman Jones becomes a legislature next session, and his son, doesn't quite hit the right mark, so we get another bill. I guess if you want 10 year olds to hunt, let them hunt but quit showing up every year and add on. We are not against young people. Young people are the core that's going to continue and we educate a lot of young people. So we're not against. We're concerned a 5<sup>th</sup> grader that's 4'6" tall and 60 lbs. Well fine, but no 9 year olds.

**Chairman Porter:** Questions? Further opposition? Seeing none then we will close the hearing on HB 1204.

The Clerk called a roll call vote. 14 Yes 0 No.

Motion carries. Rep. Roers Jones will be the bill carrier. This session closed until 10 AM to open on HB 1180.

**Chairman Porter:** Committee we have HB 1204 in front of us.

**Rep. Keiser:** I move for adoption of the amendment.

**Chairman Porter:** Rep. Keiser moves the Amendment on Page 1, Line 19 to remove the overstrike over the word twelfth or thirteenth. So it would read, eleventh, twelfth, or thirteenth birthday.

**Rep. Roers Jones:** Second from Rep. Roers Jones. Is there discussion on the amendment?

**Chairman Porter:** Seeing none all those in favor say Aye.

**Voice Vote:** Aye

**Chairman Porter:** Opposed? Motion carried. We have an amended bill in front of us.

**Rep. Bosch:** On section 2 where we're making the amendment, do the youth hunters have the requirement to have past hunter safety in that section?

**Chairman Porter:** yes they do. That's further into the section but that is a requirement that they have had hunter education safety and are always with an unarmed guardian during the season. They cannot be unattended. Further questions? Seeing none do we have a motion?

**Rep. Roers Jones:** made a motion to Do Pass as Amended for HB 1204.

**Rep. Anderson:** Seconded.

**Chairman Porter:** Discussion? Clerk will take the roll on a Do Pass as Amended to HB 1204. No, you have a point of clarification we'd like to hear it.

**Rep. Devlin (?):** when you are talking an 11 year old, we are adding an 11 year old to hunt deer during the youth season, that 11 year old may not have passed hunter safety, a 10 year old may not have passed hunter certification and that may not be spelled in there.

**Chairman Porter:** I do believe that's an important component of this. Rep. Roers Jones would have to rescind her motion and the Second would have to agree and we can further amend.

**Rep. Roers Jones:** Rescinded her motion.

**Rep. Anderson:** Rescinded his Seconded.

**Chairman Porter:** Then committee we need to further amend this so an individual who has completed the hunter safety course, who's 11-12-13<sup>th</sup> birthday occurs in the same year as the deer hunting season

**Rep. Roers Jones:** Is there a minimum age for taking the deer hunter safety course?

**Chairman Porter:** 10 years old

**Greg Link:** Allowed at 11

**Chairman Porter:** 11 then. Is there a motion to further amend?

**Vice Chairman Damschen:** So moved.

**Chairman Porter:** I have a motion from Vice Chairman Damschen to further amend HB 1204, so it would read, "An individual who has completed the hunter education course, whose 11-12 or 13 birthday occurs in the same year." Is there a second?

**Rep. Roers Jones:** So moved.

**Chairman Porter:** We have a second from Rep. Roers Jones. Discussion on the amendment now?

**Rep. Heinert:** Are we going to affect the hunter safety program by doing this amendment?

**Chairman Porter:** I don't believe so. Anyone who would take advantage of it would have to take a course inside of the start of that season in September.

**Rep. Roers Jones:** Just as a clarification, this would prevent hunters from hunting at the age of 10. They would have to have a birthday before the hunting season had started, and have turned 11, have taken the course, so that would alleviate some of Mr. Hager's concerns?

**Rep. Heinert:** That's right.

**Chairman Porter:** It would take that argument away unless Game and Fish administratively would start offering the course to 10 year olds. That's administratively for them to decide. Further discussion on the amendment? Seeing none, all in favor say Aye.

**Voice Vote:** Aye.

**Chairman Porter:** Opposed? Motion carries. Committee, we have a further amended HB 1204 in front of us.

**Rep. Roers Jones:** I will make a motion for a Do Pass recommendation

**Chairman Porter:** As amended. We have a motion,

**Rep. Ruby:** Second.

**Chairman Porter:** Second from Rep. Ruby for a Do Pass HB 1204. Discussion. For the committee's clarification, if you read the fiscal note Rep. Keiser brought up, that should take away the decrease in revenues because we fixed that portion of it and it would actually increase revenues by their estimate of the number of 11 year olds that would take a permit. Seeing no further discussion, the Clerk will call roll on a Do Pass As Amended HB 1204.

**Explanation or reason for introduction of bill/resolution: Relating to youth hunting and the protection of bald eagles.**

**Minutes:**

Attch#1and#2=GregLink; Attch#3=Michael McEnroe;

**Chairwoman Unruh:** Let's open the hearing on HB 1204.

**Representative Pat Heinert,** Dist. 32, Bismarck, ND: Here to introduce HB 1204. We talk about ages in this bill. In section 1, we moved the age from 16 to 12 year olds that do not have hunter's safety. Section 2 is an amendment to add 11 year olds into the 12-13-year-old bracket for youth deer hunting. We added who has completed the hunter education course. Game and Fish had some concerns so they will be here to chat with you about that line. The bald eagle part is put in there so local zoos, who take in eagles, can recoup and release into the wild. They can do it legally. Under federal law, they need more authority. (2.05)

**Chairwoman Unruh:** You go from 16 years down to 12 years. Isn't that a big jump? Why was this?

**Representative Heinert:** The 12-year-old is based on the hunter education program and getting into that program. The whole intent is to get them out earlier in life and provide a hobby for them and to develop a good hobby.

**Chairwoman Unruh:** Are the eagles still protected like in first bill?

**Representative Heinert:** Yes, we are not touching that.

**Greg Link,** Game and Fish, Chief Conservation/Communications Division: (see Attch#1). Here in support. I also bring forth an amendment. (see Attch#2). (3.56)

**Sen. Armstrong:** If this amendment goes through and this language is struck, they still have to take hunters safety by age 12, right?

**Greg:** Yes. That would not remove the requirement to have hunter education by 12. That is across the board. We just don't think that 10-11 year olds are old enough to comprehend and study the hunter education material, yet. They have to be with a guardian or parent to hunt.

**Sen. Oban:** If they are not at the point development wise to learn hunter safety, should they be out hunting then?

**Greg:** Good question. The apprentice portion does not remove that requirement of 12 years old. Some young kids just want to try it. They don't know if they like it. The apprentice license

just gives a one-year grace period to be out there. We have a very safe record for youth hunters.

**Chairwoman Unruh:** Do you know how long we have had the eagle protection statute?

**Greg:** Probably since 1967 when they were put into endangered species act. There was an Eagle Protection Act in the 1940's. We are asking for ability of zoos to use authority to recoup and release bald eagles.

**Chairwoman Unruh:** You still cannot have a taking of an eagle. Does this section need to be repealed? Should we just go through another permit?

**Greg:** In most cases when we have two agencies, federal and state. The feds are saying one thing and we feel we want some oversight to say all states are the same. Just because you do something for Oregon, we in ND may do it differently.

**Sen. Armstrong:** I am aware of several prosecutions under this statute, but they are all federal. Are you aware of any state prosecutions?

**Greg:** No, not sure.

**Sen. Armstrong:** Maybe it would make more sense to just say comply with the federal act?

**Greg:** Then we are turning to Fish and Wildlife side if someone gets a permit in ND. There are different states that operate in different ways. ND may not be ok with something. We are probably talking about 10 permits of this kind. Some states are more liberal about rehab than ND. If we are outing an animal through undo misery to be rehab; then at end of day they are put down. We would not want that rehab entity to have that permit to do that.

**Chairwoman Unruh:** Do you have similar authority for all migratory birds?

**Greg:** All species that cross two states that are on national level. There is a dual system.

**Chairwoman Unruh:** Any more in support? Any opposed?

**Michael McEnroe, ND Wildlife Federation:** We are against section 1 of this bill. (see Attch#3) (20.29). We support the present apprentice program.

**Sen. Armstrong:** On section 2, even with the amendment, you would not support the 11-year-old?

**Mike:** Currently 11 year olds can take hunter safety. But we don't want to require it for 11 year olds.

**Sen. Armstrong:** But the amendment offered would still allow a 10-year-old to hunt, just not have to take hunter safety?

**Mike:** Right. We support the amendment. But we have concerns with section 2.

**Chairwoman Unruh:** Any more testimony against HB 1204? Any agencies? Seeing none we will close the hearing on HB1204.

Mr. Chairman and members of the House Energy and Natural Resource Committee, I appear here today to offer support for HB 1204.

There are three parts to this bill—changing the age for apprentice hunters, addition of age 11 for antlerless youth season, and changing the language to allow possession of eagles, in particular for zoos.

First is the apprentice hunter portion. We view this as a recruitment tool for those youth that may not be sure whether or not they want to hunt and this gives them the opportunity to try it without going through the Hunter Education course. Additionally, we frequently receive calls that a parent was unable to enroll their child in a Hunter Education course because it was already full. This would allow that child 12 and over a grace period of one year to sign up for the next year's class.

Second is the antlerless youth season. The current language in this bill would limit the antlerless youth age to 11 year olds only. I've consulted with the Chairman and know this was not the intent. The intent was to allow those youth turning 11 in the calendar to hunt as well as 12 and 13 year olds. To rectify this, we recommend deleting the strikethrough on line 19 and simply insert 'eleventh' prior to 'twelfth and thirteenth' on line 19.

There are currently about 2,500 twelve and thirteen year olds that receive an antlerless deer license and approximately 2,000 fourteen and fifteen year olds that receive an any deer or mule deer license each year. Based on past applications that are eleven at the time of application but turn twelve before the end of the calendar year, we estimate that between 500 and 750 deer licenses will be issued for eleven year olds.

As currently written North Dakota Century Code 20.1-04-05, it is illegal for anyone to take, possess, disturb, kill, hunt, shoot at, capture, or destroy any golden or bald eagle or any nest or egg thereof. As you know many zoos in the State have eagles on exhibit and therefore need a permit from the United States Fish and Wildlife Service (USFWS). However, the USFWS permit states that they must follow all state laws that might pertain to the permit. By amending the Century Code 20.1-04-05 to include the words "without a permit issued by the director" golden and bald Eagles could be legally possessed by zoos and used for educational purposes.

The department respectfully requests the amendments as suggested are approved and a DO PASS recommendation.

Madam Chair Unruh and members of the Senate Energy and Natural Resource Committee, I'm testifying today on behalf of the Game and Fish Department in support of HB 1204.

There are three components to this bill, all amendments to existing law: modification to the age for apprentice hunters; addition of 11-year-old for the antlerless youth season; and change to the language allowing possession of eagles, in particular, for zoos.

First is the apprentice hunter portion. We view this as a recruitment tool for those youth who may not be sure whether they want to pursue hunting. This apprentice provision gives them the opportunity to experience hunting without going through the Hunter Education course. Additionally, we frequently receive calls that a parent was unable to enroll their child in a Hunter Education course because it was already full. This would allow that child of 12 years and older a grace period of one year to get into a class and obtain certification.

Second is the antlerless youth season. This section would add 11 year olds to the existing statutory provision entitling 12- and 13-year-old hunters to receive an antlerless deer license. There are currently about 2,500 12- and 13-year-olds who receive an antlerless deer license and approximately 2,000 14 and 15-year-olds who receive an any deer or mule deer license each year. Based on the number of past applicants who were age 11 at the time of application but turned 12 before the end of the calendar year, we estimate that between 500 and 750 additional deer licenses will be issued to 11-year-olds by this change.

Although we support this bill, we do have some concern with the amended requirement for the 11-year-old deer hunters to be Hunter Education certified. Since its inception in our state in 1972, Hunter Education certification has only been a requirement for hunters 12 years of age and older. Therefore, the entry age for the course is 11 years or older. It is only at this age of development that students are adequately equipped and capable of fully comprehending and retaining the information presented in the course. Requiring the 11-year-old deer hunter to have successfully completed a course not designed for their age development at age 10, could lead to both frustrated students and instructors. As this is a mentored hunt, with a guardian close-at-hand, we believe the requirement for Hunter Education certification isn't necessary and better left until the youth is more readily able to learn the course material at age 11 and 12. This is exactly the same scenario we currently have with young upland game and waterfowl hunters,

under age 12, being able to hunt without Hunter Education, provided they are accompanied by an adult guardian.

Third is the eagle language. Eagles are a species that have both state and federal oversight. Currently, as written in North Dakota Century Code 20.1-04-05, it is illegal for anyone to take, possess, disturb, kill, hunt, shoot at, capture, or destroy any golden or bald eagle or any nest or egg thereof. As you know, many zoos in the state have eagles on exhibit and, therefore, need a permit from the United States Fish and Wildlife Service (USFWS). However, the USFWS permit states that they must follow all state laws that might pertain to the permit. In August 2007, the bald eagle was removed from the Endangered Species list. Now many zoos have possession of bald and golden eagles through what the USFWS considered a valid permit. By changing the North Dakota Century Code 20.1-04-05 to include the words "without a permit issued by the director." golden and bald eagles can be legally possessed by zoos and used for educational purposes.

The Department respectfully requests the suggested amendment and a **DO PASS** recommendation on HB 1204.



Madam Chair Unruh and Members of the Senate Energy and Natural Resources Committee:

For the record, Mike McEnroe, representing the North Dakota Wildlife Federation.

The Federation is opposed to Section 1 of HB 1204. We support the current Apprentice Hunter validation program. When created in a past legislative session, the Apprentice validation was proposed to allow an adult who was not an experienced hunter and who had not completed a Hunter Education course to be able to hunt for a trial period of one hunting season without taking the 14-hour Hunter Education class. This was somewhat of a “try before you buy” opportunity, to see if they wanted to hunt in the future. The Apprentice idea was proposed for adults who presumably would be more responsible or more mature than an inexperienced younger hunter. Subsequent discussions lowered the age requirement for the apprentice validation to 16 years old. The Federation believes that youth, 12 to 16 years old and their parents, can still find a Hunter Education class in order to meet the state’s Hunter Education requirement. Keeping the Apprentice validation age limit at

16 years old, still avoids asking an adult, or anyone 16 years and older, to take a class with 11 and 12 year olds. We have concerns about allowing youth aged 12-16 years old to hunt without first completed a Hunter Education course.

Section 2 of HB 1204 allows 10 and 11-year old youth, who have completed a Hunter Education course to, receive a youth deer hunting license. Although we believe that when a young person begins to hunt is a decision best left up to parents, we do believe that deer hunting with a rifle is a hunting activity best left to older youth who are both physically and mentally more mature. We also question whether or not a 10-year old can handle the 14-hour Hunter Education curriculum, and we do not recommend simplifying the subject matter or the required practical exam in order to make it easier to pass. We support the Department's recommendation to eliminate the Hunter Education requirements for the 10-year old hunter.

The Federation supports the intent of Section 3 of HB 1204 regarding permits for bald and golden eagles, although we understand the intent of the bill was to allow the Director to permit the possession, capture, and transport of bald and golden eagles by zoos and other accredited raptor rehabilitation facilities, not for permits to take, kill, sell or destroy eagles.

The Federation recommends these amendments or corrections to HB 1204.
