Bruce Wessman, Executive Dir. North Dakota Board of Physical Therapy: (1.55-8.40) (see att #1) We have not had major changes since 2005. We ask for Do Pass.

Sen. Kristin Roers: I am a nurse. On page 8 and talking about the number of times you can take the test. Are there statics' how frequently more than one time to pass?

Bruce: 90 % or so pass the first time. In the ten year we have had one or testified in opposition to the bill. That could not pass the program.

Sen. Kristin Roers: Why the need to say 6 times then?

Bruce: If it does happen, the Federation State Boards wanted as many for consistency. If you can't pass in 6, you never will.

Sen. Shawn Vedaa: Why does tele-health not meet the requirements for direct supervision?

Bruce: Direct supervision in only for physical therapy aids. A PT has to be on site. Just to clarify, I guess.

Vice Chair Meyer: Did the board approve the reconfiguration?

Bruce: Yes. The chapter has been involved in approving, also. (11.1)

Chairman Weisz: Opened the hearing on SB 2125.

Senator Randy Burckhard, District 5: Introduced SB 2125. This bill is intended to bring the Physical Therapy Practice Act from Chapter 43-26.1 of the Century Code more up to date and to correct some errors and inconsistencies in the current law. The last major change in this Act was 14 years ago. To the best of my knowledge there is nothing controversial in this bill and it does not change their scope of practice. Jeanne DeKrey from the Board of Physical Therapy is here to further explain the bill.

Jeanne DeKrey, North Dakota Board of Physical Therapy: In support of SB 2125. We want to assure our supervision is appropriate to the level of education and a little less restrictive for the Physical Therapy Assistants and we want to align with what the Insurance companies say about physical therapy aides. They say it doesn't require the skills of the PTA and insurance shouldn't be paying for it. We think this will align the state to welcome more licensed providers. The second big change is to the Board composition. Currently we currently have 3 Physical Therapists, 2 Physicians and one consumer member. We want to restructure the board as it's becoming difficult to get a Physician to do volunteer work and give up a whole day from their practice. We are hoping to change that composition by keeping the 3 Physical Therapists and drop to one Physician and add a Physical Therapist Assistant to that group and increase our public member to two. The other changes we want to improve on the efficiency allowing students to get to the testing quicker. In dealing with the language on Page 9 line 25 we are trying to deal with the problem of cheating on the national level exams. Explained the language changes the Board has proposed. We are asking for a favorable consideration on SB 2125. (**See Attachment 1**).

Chairman Weisz: When you talk about changing the board composition, do you have an issue getting a public member?

Jeanne DeKrey: That has been an issue. We have asked our public members as they finish their terms is if they would help us recruit people that they think would be good and it has actually worked out pretty well. We are covering their travel costs but we don't reimburse them in any other ways.

Rep. Porter: Page 9 line 9 we have received some emails and concerns about the removal of the ability of the Physical Therapy aides to do specific tasks as directed by the Physical Therapist. Is there a reason why that has been removed and what is to gain or lose by leaving it in?

Jeanne DeKrey: We are trying to get in line with what the Blue Cross Blue Shield and Medicare are saying that unless it requires the specific skills of the Physical Therapist or a Physical Therapy Assistant they are not going to allow that to be paid. So taking Physical Therapy aides out of the picture we are just not having them provide services they are not adequately trained to provide. They are there to assist an Assistant or a Physical Therapist but they are not there to have an independent type of practice.

Rep. Greg Westlind: One of the emails said they do not perform any types of therapy. They are just there to assist in cleaning equipment is that accurate? On line 5 you still have Physical Therapy Aide in that sentence.

Jeanne DeKrey: Physical Therapy Aide our intent as a board is that they are not doing patient care aspects. They are there to help in physical components like setting up and cleaning up. In line 5 if you have an aide who is working with me I need to make sure they are safe and competent in helping with patient transfers, spotting if we are doing some balance things but not doing therapy things, and they would help with cleanup and things of that nature. We are trying to get them back into the position they were intended for and not being exploited.

Rep. Skroch: Would this also apply to CNA Aides work in long term care facilities that receive orders but are allowed to function independently?

Jeanne DeKrey: That is a different thing. The rehab aides are not looking at a physical therapy plan. It is pretty much when the patient is at a maintenance time and not an insurance billable issue.

Rep. Westlind: Are we penalizing them because Blue Cross Blue Shield thinks they are doing work and getting paid for it? Isn't it more of a jurisdiction issue as to watching these people to make sure they are not doing actual physical therapy and creating an illegal payment?

Jeanne DeKrey: 0:12:25. I think it is a question we have as a board such as can I have an aide do this? We told the Physical Therapist it is ultimately their responsibility and their license and I think there is some situations where they are pressured to bend those lines a little and we are hoping to give them better guidelines. It's important to have them revisit the guidelines.

Vice Chairman Rohr: Back to the composition of your board and moving it from two positions to one. You aren't limited with technology could they skype in or have you tried that?

Jeanne DeKrey: No we haven't tried that. Maybe we need to be more creative as well. We hold 1 full day of meetings, but technology may be applicable.

Kevin Axman, North Dakota Physical Therapy Association: After sharing these changes with the Association and we have received no opposition. As an Association we are in support of SB 2125.0:14:56

Chairman Weisz: Any further support of SB 2125? Any opposition? Seeing none.

SEN. DAVISON AND COMMITTEE MEMBERS:

My name is Bruce Wessman. I'm the executive director of the North Dakota Board of Physical Therapy. I'm appearing here this morning to explain the changes the Board has made in its Practice Act. These changes are being made to bring the Act a bit more up-to-date – the last substantive changes were made in 2005; to bring the Act more in line with the Model Act proposed by the Federation of State Boards of Physical Therapy (FSBPT); and to correct some errors and inconsistencies.

On page 1, line 19, dealing with direct supervision, this change was made to recognize that physical therapists (PTs) have three levels of supportive personnel they supervise. Direct supervision is for aides as they require the most stringent level of supervision.

On page 2, line 7, general supervision was added as this is the normal level of supervision for physical therapist assistants (PTA's) from neighboring states. The current law is more restrictive and was thought to be a hindrance in the ability to hire PTAs.

On page 2, line 14, the changes were made to provide for student supervision. Physical therapy aides require direct supervision.

On page 4, starting on line 5, we made some changes in Board composition since it has been difficult for the Governor's Office to recruit physicians to serve on the Board. Under current law, the Board consists of three licensed PTs, two physicians, and one public member. Under our changes, there will be three PTs, one licensed physician, one licensed PTA and two public members. Adding another consumer member will make the number of non-PT's greater than the number of PT's which may be important after the North Carolina dental board ruling.

The change on page 5, line 7, corrects an oversight in previously omitting PTAs.

The changes starting on line page 5, line 24, were made to protect the privacy of licensees, patients and medical records during investigations.

On page 6, beginning on line 14, we made sure that PTAs were included. They should have been there all along.

On page 7, line 9, we added information concerning the criminal history background checks that the Board began using after the 2017 Legislature gave us authority to do so.

On page 8, starting on line 1, we made changes to allow North Dakota to participate in an alternate approval pathway for students applying to take the National Physical Therapy Examination (NPTE). This will be a more efficient method for students. The standards set out at lines 6 and 7 are the standards set by the FSBPT after extensive, nation-wide study.

The fee added on page 8, line 22, reflect fees required to participate in the Physical Therapy Licensure Compact (Ch. 43-26.2, NDCC) authorized by the 2017 Legislative Assembly.

The changes on page 9, line 9, clarify that a physical therapist aide should not be involved with patient care that is considered skilled therapy. This is a requirement of both Medicare and North Dakota Blue Cross/Blue Shield.

On page 9, line 23, we added language to make it clear the PT is in charge of overall patient care and in communicating with the patient or his or her representatives.

Our current law is more restrictive and is thought to be a hindrance in the ability to recruit and utilize PTAs.

- Page 2, line 14, changes are proposed made to provide for student supervision.

- Page 3, line 26, includes as updated definition of "Telehealth"

- Page 4, starting on line 5, we hope to make changes in Board composition since it has been difficult for the Governor's Office to recruit physicians to serve on the Board. Under current law, the Board consists of three licensed PTs, two physicians, and one public member. Under proposed changes, there will be three PTs, one licensed physician, one licensed PTA and two public members. Adding another consumer member will make the number of non-PT's greater than the number of PT's which may be important after the North Carolina dental board ruling.

- Page 5, line 7, corrects an oversight in previously omitting PTAs.

- The changes starting on line page 5, line 24, are proposed to protect the privacy of licensees, patients and medical records during investigations.

- Page 6, beginning on line 14, we have included PTAs. Again, this corrects an oversight as they should have been included all along.

- Page 7, line 9, we added information concerning the criminal history background checks that the Board began using after the 2017 Legislature authorized us to do so.

- Page 8, starting on line 1, proposed changes would allow North Dakota to participate in an alternate approval pathway for students applying to take the National Physical Therapy Examination (NPTE). This will be a more
