

## LEGISLATIVE REREFERRAL AND REPORTING DEADLINES - PROPOSED AMENDMENTS

The table below illustrates current deadlines and as proposed by the first draft, second draft, and third draft of the Proposed Amendments to Senate and House Rules 329(4) and 508, Senate Rule 402(3), House Rule 402(4), and Joint Rule 203.

The table also indicates the number of legislative days 3-day and 2-day committees have to hear bills between final introduction and rereferral deadlines, e.g., H3d=6 means the House 3-day committees have 6 scheduling days after a final introduction or crossover deadline before rereferral to the Appropriations Committee is required--introduction deadline is Monday, January 17; first day available to be scheduled for hearing (hearing schedules are

prepared either Wednesday or Thursday for the following week) is Monday, January 24; deadline for rereferral is Thursday, February 3 = 6 legislative days. Appropriations Committee numbers indicate the number of scheduling days between a final introduction and the reporting deadline and between rereferral and the reporting deadline, e.g., HApprop=17/7 means introduction deadline is Monday, January 17, reporting deadline is Tuesday, February 15 = 17 scheduling days; rereferral deadline is Thursday, February 3 = 7 scheduling days. Available days reflect the worst-case scenario under the rules.
