

CORRECTIONAL OFFICER SALARIES - NORTH DAKOTA AND SURROUNDING STATES

This memorandum compares salaries paid to state correctional officers in North Dakota and surrounding states and provides information on the effect of the amount appropriated by the 2001 North Dakota Legislative Assembly for additional state correctional officer salary increases.

The 2001 survey includes the following information on average annual salaries for positions determined to be equivalent to the North Dakota classification for correctional officer II. The average annual salary is affected by employees' average years of service, turn-over rates, starting salaries, the frequency of promotion to higher pay grades, and other factors.

ADDITIONAL SALARY INCREASES PROVIDED TO NORTH DAKOTA CORRECTIONAL OFFICERS

In addition to funding for regular salary increases provided by the Legislative Assembly for all state employees (3 percent the first year, 2 percent the second year, with a minimum of \$35 per month), the 2001 Legislative Assembly appropriated \$222,528 from the general fund for additional salary increases for correctional officers. No amounts were appropriated by previous Legislative Assemblies for this purpose. The appropriation was used to increase correctional officer I and II salaries as follows:
