¹ The conference committee amended the bill to provide funding of \$1,300,000, of which \$500,000 is from the general fund, to the Department of Human Services for the costs associated with establishing a pilot program at the State Hospital or at a private treatment facility for the treatment of individuals who are chemically dependent on methamphetamine or other controlled substances. The funds provided may not be used for the cost of any facility construction or renovation project.

Section 42 of House Bill No. 1015 authorizes up to 21 additional FTE positions at the State Hospital relating to the provisions of Senate Bill No. 2373, subject to approval by the Emergency Commission and the Budget Section.
