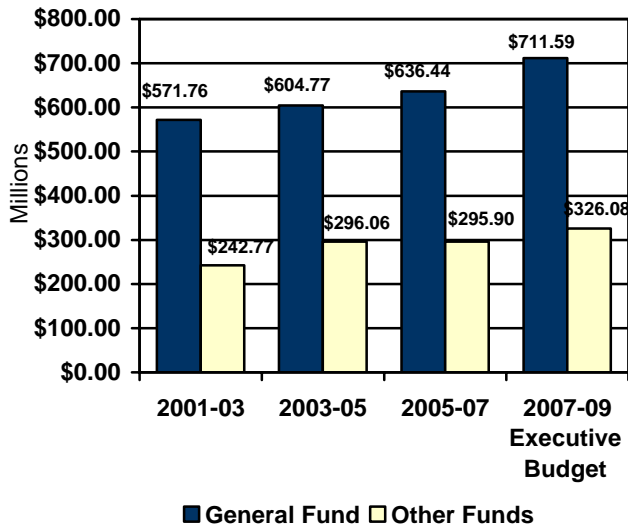

**State School Aid Program**

The executive budget recommends consolidating funding for the state school aid program, including per student payments, teacher compensation payments, special education average daily membership payments, revenue supplemental payments, and tuition apportionment payments, into a new state school aid funding formula. In addition, the executive budget recommends providing funding of \$16.5 million from the general fund for equity payments to school districts and \$3 million from the general fund for full-day

kindergarten for at-risk students beginning with the 2008-09 school year. The funding for the state school aid program is summarized as follows:

### Other Sections in Bill

**2005-07 appropriation** - Section 4 provides a \$22 million special funds appropriation to the Department of Public Instruction for operating expenses (\$2 million) and providing grants to school districts (\$20 million) during the 2005-07 biennium.

**Special education gifted and talented programs** - Section 7 provides that \$400,000 of the amount appropriated for state school aid must be used to reimburse school districts or special education units for gifted and talented programs upon the submission of an application that is approved in accordance with guidelines adopted by the Superintendent of Public Instruction.

**Payments for English language learner students** - Section 8 provides that \$650,000 of the amount appropriated for state school aid is for payments to school districts educating English language learner students as provided in NDCC Section 15.1-27-12.

### Continuing Appropriations

**Instructional materials revolving printing fund** - NDCC Section 15.1-03-03 - The fund is used for revenues and expenses associated with distributing instructional materials developed and printed by the department.

**Displaced homemaker program** - NDCC Chapter 14-06.1 - The fund is used to provide counseling, guidance, job readiness training, and services for displaced homemakers.

### Major Related Legislation

**Senate Bill No. 2023** - This bill provides a \$275,000 general fund deficiency appropriation for the 2005-07 biennium for operating expenses for the department.

**Senate Bill No. 2108** - This bill changes the definition of a student with a disability for special education purposes to align the definition with federal regulations.

**Senate Bill No. 2184** - This bill increases the length of the school calendar.

**Senate Bill No. 2200** - This bill includes the provisions for a new state school aid program, including consolidating per student payments, teacher compensation payments, special education average daily membership payments, revenue supplemental payments, and tuition apportionment payments into a new state school aid funding formula. The bill also includes:

- A \$2 million general fund appropriation to the Superintendent of Public Instruction for providing joint powers agreement incentives.
- A \$1.2 million general fund appropriation to the State Board of Career and Technical Education for providing grants to assist with the establishment of two area career and technology centers.

- A \$800,000 general fund appropriation to the State Board for Career and Technical Education for funding the cooperative delivery of career and technical education.
- A \$10 million general fund appropriation to the Superintendent of Public Instruction for awarding school districts deferred maintenance and physical plant improvement grants contingent upon an ending balance exceeding \$30 million.
- Contingent distributions of state school aid funding appropriated for the 2007-09 biennium.
- A contingent transfer from Bank of North Dakota earnings and accumulated and undivided profits in the amount the Superintendent of Public Instruction determines necessary to fully reimburse school districts for the excess costs of serving the 1 percent of special education students statewide who require the greatest school district expenditures.

**Senate Bill No. 2309** - This bill increases high school coursework requirements.

**Senate Bill No. 2388** - This bill changes the contingent distribution provisions for state school aid funding for the 2005-07 biennium.

**House Bill No. 1169** - This bill removes the statutory requirement that the Superintendent of Public Instruction hold a valid North Dakota professional teaching license.

**House Bill No. 1178** - This bill amends the contingent distribution provisions for funds appropriated for reorganization bonuses for the 2005-07 biennium.

**House Bill No. 1320** - This bill provides a \$225,000 general fund appropriation for providing grants to school districts offering prekindergarten programs and for administrative fees and monitoring expenses.

**House Bill No. 1372** - This bill provides for a Legislative Council study of teacher mentoring programs.
