- 2 relating to authority of the state board of higher education to provide authorizations to operate
- 3 private postsecondary educational institutions offering instruction at the associate in arts level or
- 4 higher and to false academic degrees and accreditation mills; to amend and reenact
- 5 subsections 1, 4, 7, and 10 of section 15-20.4-01, sections 15-20.4-02 and 15-20.4-02.1,
- 6 subsections 1, 2, 3, 4, 5, and 8 of section 15-20.4-03, sections 15-20.4-03.1 and 15-20.4-04,
- 7 subsections 1 and 2 of section 15-20.4-05, sections 15-20.4-06, 15-20.4-08, 15-20.4-09, and
- 8 15-20.4-13, and subsection 1 of section 15-20.4-14, of the North Dakota Century Code, relating
- 9 to authority of the state board for career and technical education to provide authorizations to
- 10 operate private postsecondary career schools offering instruction at the level of no higher than
- 11 the associate of applied science level; to repeal sections 15-20.4-15, 15-20.4-16, 15-20.4-17,
- 12 and 15-20.4-18 of the North Dakota Century Code, relating to false academic degrees and
- 13 accreditation mills; and to provide a penalty.

14 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 15 **SECTION 1.** Chapter 15-18.1 of the North Dakota Century Code is created and enacted as
- 16 follows:
- 17 **15-18.1-01. Definitions.**
- 18 <u>As used in this chapter:</u>
- 1. "Authorization to operate" or like term means approval of the board to operate or to contract to operate a private postsecondary educational institution in this state.
- 21 <u>2.</u> "Board" means the state board of higher education.
- 22 <u>3.</u> "Education" or "educational services" or like term includes any class, course, or
- 23 program of training, instruction, or study.

- "Educational credentials" means degrees, diplomas, certificates, transcripts, reports,
 documents, or letters of designation, marks, appellations, series of letters, numbers, or
 words which signify, purport, or are generally taken to signify enrollment, attendance,
 progress, or satisfactory completion of the requirements or prerequisites for education
 at a postsecondary educational institution operating in this state.
 "Entity" includes a company, firm, society, association, partnership, corporation, limited
- 5. "Entity" includes a company, firm, society, association, partnership, corporation, limited
 liability company, or trust.
- general secondary educational institution" means a private academic, technical, home study, business, professional, or other private school, college, or university, or other private organization or person, operating in this state, offering educational credentials, or offering instruction or educational services, primarily to persons who have completed or terminated their secondary education or who are beyond the age of compulsory high school attendance, for attainment of educational or professional objectives at the associate in arts level or higher.
 - 7. "To grant" includes awarding, selling, conferring, bestowing, or giving.
- 8. "To offer" includes, in addition to its usual meanings, advertising, publicizing, soliciting,
 or encouraging any person, directly or indirectly, in any form, to perform the act
 described.
- "To operate" an educational institution, or like term, means to establish, keep, or
 maintain any facility or location in this state where, from, or through which, education
 is offered or given, or educational credentials are offered or granted, and includes
 contracting with any person, group, or entity to perform any such act.

15-18.1-02. Exemptions.

- The following education and educational schools or institutions are exempt from the provisions of this chapter:
- Education sponsored by a bona fide trade, business, professional, or fraternal
 organization, so recognized by the board, solely for that organization's membership, or
 offered on a no-fee basis.

- 1 Prescribe forms and conditions for, receive, investigate as it may deem necessary, and 2 act upon applications for authorization to operate postsecondary educational 3 institutions.
- 4 Maintain a list of postsecondary educational institutions authorized to operate in this 3. 5 state under the provisions of this chapter. The list must be available for the information 6 of the public.
- 7 Negotiate and enter into interstate reciprocity agreements with similar agencies in 4. 8 other states, if in the judgment of the board such agreements are or will be helpful in 9 effectuating the purposes of this chapter; provided, however, that nothing contained in 10 any such reciprocity agreement may be construed as limiting the board's powers, duties, and responsibilities with respect to independently investigating or acting upon 12 any application for authorization to operate or any application for renewal of such 13 authorization to operate, a postsecondary educational institution, or with respect to the enforcement of any provision of this chapter, or any of the rules adopted hereunder.

Adopt such rules and procedures necessary or appropriate for the conduct of its work and the implementation of this chapter, and hold such hearings as it may deem advisable in accordance with chapter 28-32, or as required by law in developing such rules and procedures, or in aid of any investigation or inquiry.
 - <u>7.</u> Investigate as it may deem necessary, on its own initiative or in response to any complaint lodged with it, any person, group, or entity subject to, or reasonably believed by the board to be subject to, the jurisdiction of this chapter; and in connection therewith to subpoena any persons, books, records, or documents pertaining to such investigation. The board may require answers in writing under oath to questions propounded by the board and may administer an oath or affirmation to any person in connection with any investigation. The board may, after hearing, revoke or suspend authorizations to operate. Subpoenas issued by the board are enforceable by any district court.

student than the schedule described in subsection 1.

1 15-18.1-09. Cancellation of contract for instrument. 2 A person has the right for any cause to rescind, revoke, or cancel a contract for educational 3 services at any postsecondary educational institution within seven days after entering into such 4 contract without incurring any tort or contract liability. In such event, the postsecondary 5 educational institution may retain the amount of tuition and other charges as set forth in 6 subsection 1 of section 15-18.1-08. 7 15-18.1-10. Remedy of defrauded student - Treble damages. 8 A person defrauded by an advertisement or circular issued by a postsecondary educational 9 institution, or by a person who sells textbooks to the institution or to the pupils thereof, may 10 recover from such institution or person three times the amount paid. 11 15-18.1-11. Board review. 12 A person aggrieved by a decision of the board respecting denial or revocation of an 13 authorization to operate, or the placing of conditions thereon, whether on initial application or on 14 application for renewal, and a person aggrieved by the imposition of a penalty by the board 15 under section 15-18.1-13, has the right to a hearing and review of such decision by the board 16 and to judicial review in accordance with chapter 28-32. 17 15-18.1-12. Violations - Civil penalty. 18 A person, group, or entity, or an owner, officer, or employee thereof, who violates the 19 provisions of section 15-18.1-07, or who fails or refuses to deposit with the board the records 20 required by the board under this chapter, is subject to a civil penalty not to exceed one hundred 21 dollars for each violation. Each day's failure to comply with the provisions of these sections is a 22 separate violation. Such fine may be imposed by the board in an administrative proceeding or 23 by any court of competent jurisdiction. 24 15-18.1-13. Violations - Criminal penalty. 25 A person, group, or entity, or an owner, officer, or employee thereof, who willfully violates 26 the provisions of section 15-18.1-07, or who willfully fails or refuses to deposit with the board 27 the records required by the board under this chapter, is guilty of a class B misdemeanor. The 28 criminal sanctions may be imposed by a court of competent jurisdiction in an action brought by 29 the attorney general of this state or a state's attorney pursuant to section 15-18.1-15.

1 <u>15-18.1-14. Jurisdiction of courts - Service of process.</u>

2 A postsecondary educational institution not exempt from this chapter, which has a place of 3 business in this state, and which instructs or educates, or offers to instruct or educate, enrolls or 4 offers to enroll, or contracts or offers to contract, to provide instructional or educational services 5 in this state, whether such instruction or services are provided in person or by correspondence, 6 to a resident of this state, or which offers to award or awards any educational credentials to a 7 resident of this state, submits such institution, and if a natural person, the person's personal 8 representative, to the jurisdiction of the courts of this state, concerning any claim for relief 9 arising therefrom, and for the purpose of enforcement of this chapter by injunction pursuant to 10 section 15-18.1-15. Service of process upon an institution subject to the jurisdiction of the 11 courts of this state may be made by personally serving the summons upon the defendant within 12 or outside this state, in the manner prescribed by the North Dakota Rules of Civil Procedure, 13 with the same force and effect as if the summons had been personally served within this state. 14 Nothing contained in this section limits or affects the right to serve any process as prescribed by 15 the North Dakota Rules of Civil Procedure.

The attorney general of this state, or the state's attorney of any county in which a postsecondary educational institution is found, at the request of the board or on the attorney general's own motion, may bring any appropriate action or proceeding, including injunctive proceedings, or criminal proceedings pursuant to section 15-18.1-13, in any court of competent jurisdiction for the enforcement of the provisions of this chapter.
- Whenever it appears to the board that a person, group, or entity is, is about to, or has been violating any of the provisions of this chapter or any of the lawful rules or orders of the board, the board may, on its own motion or on the written complaint of any person, file a petition for injunction in the name of the board in any court of competent jurisdiction in this state against such person, group, or entity, for the purpose of enjoining such violation or for an order directing compliance with the provisions of this chapter, and all rules and orders issued hereunder. It is not necessary that the board allege or prove that it has no adequate remedy at law.  operate in this state under the provisions of this chapter. The list must be available for
 the information of the public.
 - 4. Negotiate and enter into interstate reciprocity agreements with similar agencies in other states, if in the judgment of the board such agreements are or will be helpful in effectuating the purposes of this chapter; provided, however, that nothing contained in any such reciprocity agreement may be construed as limiting the board's powers, duties, and responsibilities with respect to independently investigating or acting upon any application for authorization to operate, or any application for renewal of such authorization to operate, a postsecondary educational institutioncareer school, or with respect to the enforcement of any provision of this chapter, or any of the rules or regulations promulgated hereunder.
 - 5. Receive and cause to be maintained as a permanent file, copies of academic records specified by the board in the event any postsecondary educational institution career

- school required to have an authorization to operate under this chapter proposes to
 discontinue its operation.
 - 8. Require fees and bonds from postsecondary educational institutions career schools in such sums and under such conditions as it may establish; provided, that fees established may not exceed the reasonable cost of the service being provided.
 - **SECTION 6. AMENDMENT.** Section 15-20.4-03.1 of the North Dakota Century Code is amended and reenacted as follows:

8 15-20.4-03.1. Authorization Career school fee fund.

There is created an authorizationa career school fee fund into which fees provided to the board upon application for authorization to operate a postsecondary educational institution career school under section 15-20.4-03 must be deposited. The fund and interest earned on the fund may be spent by the board pursuant to legislative appropriation exclusively to carry out the intent and purpose of this chapter. This fund is not subject to section 54-44.1-11.

SECTION 7. AMENDMENT. Section 15-20.4-04 of the North Dakota Century Code is amended and reenacted as follows:

15-20.4-04. Minimum standards - Exceptions.

- 1. All postsecondary educational institutionscareer schools must be accredited by national or regional accrediting agencies recognized by the United States department of education. The board may additionally require such further evidence and make such further investigation as in its judgment may be necessary. Any postsecondary educational institutioncareer school operating in this state seeking its first authorization to operate may be issued a provisional authorization to operate on an annual basis until the institutionschool becomes eligible for accreditation by a recognized accrediting agency. InstitutionsSchools issued a provisional authorization to operate must demonstrate a substantial good-faith showing of progress toward such status. Only upon accreditation shall an institutiona school become eligible for a regular authorization to operate.
- 2. This section does not apply to postsecondary educational institutionscareer schools operating in this state that do not grant degrees and that offer mainly hands-on training in low census occupations, as determined by the board. "Degree" as used in this subsection means a document that provides evidence or demonstrates completion of
