- One-time funding for park improvement projects is reduced by \$7.65 million to provide a total of \$14.75 million, of which:
  - \$3 million is for the Lewis and Clark Interpretive Center, of which \$2,050,000 for the transfer of the center and certain assets from the Lewis and Clark Foundation and \$950,000 is for operating costs for the Lewis and Clark Interpretive Center for the 2015-17 biennium, the same as the House version. The House version provided \$9.9 million to be used at the discretion of the Director of the Parks and Recreation Department.
  - Up to \$11.75 million may be used at the discretion of the Director of the Parks and Recreation Department for any state park enhancement projects including consideration of the repair, removal, or replacement of a timber bridge at the Roughrider Bridge trail. The Director shall use up to \$222,000 of the \$11.75 million to match federal funds for the purchase of property adjacent to the north boundary of Fort Abraham Lincoln State Park.

#### In addition, the Conference Committee did not include:

- \$25,000 from the general fund for a study of the feasibility and desirability of a new state park.
- One-time funding of \$310,299 from the general fund for website application for snowmobile registration, which is removed by an amendment to Senate Bill No. 2019 in **Senate Bill No. 2015**.
