



Continuing Appropriations

Veterans' aid fund - North Dakota Century Code Section 37-14-03.3 - The purpose of the veterans' aid fund is to make loans or advancements to any veteran and to a surviving spouse of a veteran if the spouse has not remarried.

Deficiency Appropriation

There are no deficiency appropriations for this agency.

Significant Audit Findings

The performance audit for the Department of Veterans' Affairs conducted by the State Auditor's office for the period ending September 30, 2017, identified the following significant audit recommendations for the Department of Veterans' Affairs:

- Establish underwriting guidelines for determining an applicant's financial ability to repay a veteran's aid loan;
- Adhere to the Administrative Committee on Veterans' Affairs (ACOVA) loan collection policies and procedures for delinquent loans;
- Comply with the Information Technology Department's requirements for outsourcing information technology services instead of entering into service agreements with third-party vendors for hosting services;
- Review policies for clarity, continued relevance, and effectiveness in achieving the objectives of the hardship assistance grants program;
- Propose policy and objective refinements for the hardship assistance grants program to ACOVA for approval;
- Obtain an effective information system to meet the objectives of the hardship assistance grant program; and
- Use state resources and expend private funds in accordance with state laws and receive legislative or Emergency Commission approval to expend private funds.

The performance audit for the veterans' affairs oversight structure conducted by the State Auditor's office for the period ending March 28, 2018, discussed challenges and disagreements regarding veteran services and processes between the Department of Veterans' Affairs, ACOVA, veteran service organizations, State Treasurer's office, and county and tribal veterans' service officers, however, no official audit recommendations were issued.

Major Related Legislation

House Bill No. 1128 - Provides an appropriation of \$50,000 from the general fund to the Department of Veterans' Affairs for the purpose of training up to four service dogs to assist North Dakota veterans with posttraumatic stress disorder during the 2019-21 biennium.

House Bill No. 1129 - Requires the Commissioner of Veterans' Affairs to coordinate with any federal agency or state public or private entity to fulfill the Commissioner's duties.

House Bill No. 1130 - Allows ACOVA to establish goals and objectives for the expenditures of the veterans' postwar trust fund, and make recommendations to the State Treasurer for consideration when investing the fund.

House Bill No. 1131 - Allows the Department of Veterans' Affairs to apply for, accept, and expend private donations, gifts, grants, or bequests that are offered or tendered with a specifically identified purpose or a restrictive condition which is related to a benefit or service for resident North Dakota veterans and provided those funds are appropriated to the department on a continuing basis in accordance with the donor's instructions. The bill also exempts gross receipts from all sales of commemorative memorial coins from sales tax.

House Bill No. 1168 - Provides an appropriation of \$18,800 from the general fund to the Department of Veterans' Affairs for the purpose of purchasing one transport van to provide medical-related transportation services for North Dakota veterans during the 2019-21 biennium.

House Bill No. 1177 - Provides an appropriation of \$150,000 from the general fund to the Department of Veterans' Affairs for the purpose of developing and administering a national veterans' service officer grant program for the 2019-21 biennium. Of this amount, the department is required to provide a grant of up to \$50,000 to each North Dakota veterans' service organization with a national veterans' service officer.

House Bill No. 1178 - Provides an appropriation of \$10,000 from the general fund to the Department of Veterans' Affairs for the purpose of stand down events during the 2019-21 biennium.




