## **INTERIM COMMITTEE MEASURES - SPONSORSHIP AND DISPOSITION - 2007**

This table depicts the final disposition of bills recommended by the Legislative Council as the result of Legislative Council studies during the 2005-06 interim. With respect to 2007 legislative action on the 941 bills that were introduced: 48 out of 49 appropriation bills were enacted (98 percent); 22 out of 33 Legislative Council bills were enacted (67 percent); and of the remaining bills, introduced by individual legislators or at the request of state agencies (agency bills), 505 out of 859 were enacted (59 percent).
